Rider Contracts and Benefits
2021 Season (Jan 2021-Dec 2021)

Expectations

Members of the St. Nicholas Brewing Company Cycling Team can choose to be club members or team members:

- **Club Members** must pay dues
- **Team/Club Members** must pay dues, participate in at least 10 training rides per year and fulfill expectations for one of the following tiers:
 - Tier 1- Participate in at least 10 “organized event”¹ rides throughout the calendar year.
 - Tier 2 – Participate in at least 5 “organized event”¹ rides throughout the calendar year.

Dues *must be paid prior to March 28, 2021*

- Club Member Dues=25\$ or the cost of a team jersey (ordered from Champion System)
- Team Member Dues=Cost of a full kit (jersey and bibs or shorts-ordered from Champion systems)

Training Ride Participation will be on the honor system.

Team training rides will include:

- Group rides that leave from the St. Nick or other established locations
- Other impromptu group rides throughout the area (will be posted on the Facebook page or team website)

¹ “organized event” rides are defined as any riding event that requires registration such as organized charity rides, tour, or races and club/team member is wearing SNBC Cycling jersey/kit. We want you to ride, be involved, and represent our team/club!

Benefits (may require presenting club/team membership card)

1. The Bike Surgeon of Carbondale will give all club/team members, and immediate family, a discount according to the following schedule for all equipment and accessory purchases, excluding bikes and wheels*

- Team/club – Tier 1 = 20% discount
- Team/club – Tier 2 = 15% discount
- Club Member = 10% discount

In addition, all club/team members will receive 1 free bike fit (appointment only) and 50% off labor costs (appointment preferred**). Discounts cannot exceed shop costs for service or product.

2. St. Nicholas Brewing Company will offer dollar off house pints to all club or team members (members must spend at least \$10 on food and present membership card, offer valid at Du Quoin and Chester locations)

3. Cycle1 Studio will give all club/team members a \$10 per month discount according to the following schedule:

- Team/club – Tier 1 = up to three months
- Team/club – Tier 2 = up to two months
- Club Member = up to one month

4. Hair Brains of Carbondale will give all club/team members a 10% discount for services provided.

5. Managing Broker Paula Arpasi of Homefinders Realty will give all club/team members a discounted commission rate to list their property or provide a one-year home warranty for those looking to purchase a home (a \$498 value with a minimum of \$50,000 purchase)
